

Announcement No.71 of the Ministry of Commerce of the People's Republic of China dated 2016 on the mid-term review of anti-dumping measures applicable to imported solar grade polysilicon originating in South Korea

January 20, 2014, Ministry of Commerce issued Announcement No. 5 year, decided that, effective January 20, 2014, originating in the United States and South Korea's imports of solar grade polysilicon impose [anti-dumping](#) duties.

February 14, 2016, [Jiangsu Zhongneng Polysilicon Technology Development Co., Ltd.](#), [Jiangxi LDK LDK Solar Silicon Technology Co., Ltd.](#), [Luoyang Sino-silicon High-tech Co.,](#) [Chongqing New Energy Co., Ltd.](#) (hereinafter referred to as the domestic industry the applicant) apply to the Ministry of Commerce, South Korea's exports to China after claims of solar grade polysilicon final dumping margin increased over the final determination of the anti-dumping duties, requires anti-dumping measures originating in South Korea's imports of solar grade polysilicon will be applicable Dumping and dumping margin.

According to the relevant provisions of Article 49 and the Ministry of Commerce, "interim dumping and dumping margin review of the Provisional Rules," "People's Republic of China Anti-dumping Regulations", the Ministry of Commerce of the qualifications of the applicant, the export price of the product under investigation and apply the normal value, continue according to the original the implementation of the action level of anti-dumping measures and the necessity of the situation were examined. The Ministry of Commerce asks the applicant of the domestic industry to supplement and submit the relevant evidential materials; the applicant has submitted the related materials within the prescribed time limit.

November 1, 2016, the Ministry of Commerce received dumping and dumping margin mid-term review of the application notify the South Korean Embassy, and its disclosure transmitted an interim review of the application and non-confidential summary of confidential information. Interested parties submitted comments on the mid-term review of the filing.

Following a review of the Ministry of Commerce believes that the application in line with "People's Republic of China Anti-dumping Regulations" and "interim dumping and dumping margin review of the Provisional Rules" statutory conditions. Ministry of Commerce decided the date of this announcement to start anti-dumping measures originating in South Korea's imports of solar grade polysilicon applicable dumping and dumping margin mid-term review. The relevant matters of re-examination are hereby announced as follows:

1. Review the scope of the investigation

The mid-term review of dumping and dumping margin range of products originating in South Korea's imports of polysilicon solar grade. Detailed description and the Ministry of Commerce 2014 No. 5 announcement requirements consistent with the product description.

Second, review the investigation period

The investigation of dumping and dumping margin for the review period 1 January 2015 to 31 December 2015.

Third, the review process

(1) Stakeholder comments.

Any interested party may from the date of this announcement in writing within 20 days of the review comments, and provide appropriate evidence.

(2) Questionnaire distribution.

In order to obtain the information required by the Ministry of Commerce, the Ministry of Commerce will send the questionnaire to the relevant stakeholders as required. Questionnaire in this case the Ministry of Commerce website [Trade Remedy Investigation Bureau](#) subsite (at <http://trb.mofcom.gov.cn>) "Dynamic case" section to download. Respondents to the questionnaire should be made according to the requirements of the questionnaire submitted 37 days after the date sent in the questionnaire.

(3) Hearings.

Interested parties may submit in writing a hearing in accordance with the "People's Republic of China Anti-dumping Regulations" and the Ministry of Commerce "anti-dumping investigation hearings provisional rules," the request, the Ministry of Commerce deems necessary, may also take the initiative to hold a hearing.

(D) on-site verification.

The MOFCOM shall send personnel to the relevant countries for on-the-spot verification when necessary. Any materials submitted by the interested parties shall include the statement of consent to the verification; prior to the verification, the MOFCOM shall notify the relevant countries and enterprises in advance.

Fourth, the consequences of non-cooperation

In accordance with Article 21 of the Anti-dumping Regulations of the People's Republic of China, when the Ministry of Commerce conducts an investigation, the interested parties shall truthfully reflect the relevant information and provide relevant information. Where the interested party does not truthfully provide information, or fails to provide necessary information within a reasonable time, or otherwise seriously impedes the investigation, the MOFCOM may make a ruling on the facts already obtained and the best information available .
